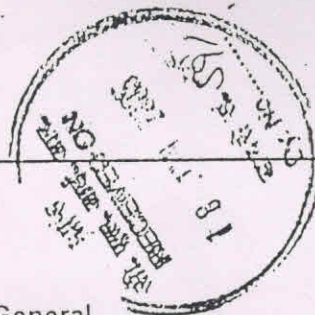

Sub : Infringement of the Stay Order by DGCSIR

The Working Committee Members of the All-India Association of CSIR Employees (AIACE) / Federation visited New Delhi in order to hold a meeting. Accordingly, the WC members held a meeting in the Maharani Bagh Guest House on 25<sup>th</sup> December 2004 to review the AIACE's activities and to discuss on the very vital issue relating to CCS(RSA) Rules-1993.

As certain papers, which were kept in the AIACE/Federation's office room (No. EG-6) were required by the Office Bearers, all the WC members moved near the AIACE Office to collect the same. To the utter surprise of all the WC members, it was found that the locks of the Office Room door were broken and the same have been replaced with another lock by the CSIR authorities, whose key is in possession of the In-charge, Maharani Bagh Guest House. On an enquiry, we were given to understand that the CSIR has taken the possession of the AIACE Office Room and have been using the same as Store Room. All the WC members were shocked to know this.

We could not enter into the Office Room and also could not hold the meeting in the Office Room. We are apprehensive that even important files, things/materials belonging to the AIACE and furniture allotted by the CSIR have all been tampered/sabotaged by the CSIR authorities.

It may be recalled that the AIACE/Federation and CFTRI Employees' Union (Mysore) had filed a Writ Petition before the Karnataka High Court against eviction of the AIACE/Federation Office Room from Maharani Bagh Guest House in pursuance of order bearing No. 12-6(36)/MBSA/2002-E-III/Estate dated 8.8.2003. Subsequently, vide its Writ Petition No. 37278/2003 (L-RES) and 37840/2003 dated 23.8.2003, the Hon'ble Karnataka High Court had granted STAY of the above Order seeking eviction, and as of date the STAY ORDER IS STILL IN FORCE. A copy of the Stay Order is enclosed herewith.

All the Working Committee Members present in the meeting unanimously resolved to pursue the matter legally for initiating contempt of court proceedings against Director-General, CSIR.




